- During the F.Y., 2022-23, the Corporate Insolvency Resolution Process (CIRP) of M/s. Polar Marmo Agglomerates Limited had been initiated vide the order dated 23.06.2022 of Hon'ble NCLT, Jaipur Bench under Section 9 of the Insolvency and Bankruptcy Code, 2016 (IBC) in the matter of Polar Marmo Agglomerates Limited, "the Company" & amp; Bakelite Hylam Ltd. & amp; Anr., "the operational Creditor". Further pursuant to the said Order, Mr. Hari Babu Sharma, bearing Registration No. IBBI/IPA-002/IP-N00767/2019-20/12477 was appointed as the Interim Resolution Professional (IRP) from the date of the Order and the powers of the Board of Directors of the Company were also stood suspended during the pendency of the proceedings and was exercised by Mr. Hari Babu Sharma till the time he continued to act as the IRP/Resolution Professional.
- However, as both the parties, i.e., Polar Marmo Agglomerates Limited, and; Bakelite Hylam Ltd. have entered into a settlement in terms of Section 12A of the Insolvency and Bankruptcy Code, the Hon'ble National Company Law Appellate Tribunal (NCLAT) vide its order dated 06.01.2023 has allowed the appeal filed by the Company against the order dated 23.06.2022 passed by the National Company Law Tribunal, Jaipur Bench. Pursuant to the order dated 06.01.2023 passed by the Hon'ble National Company Law Appellate Tribunal (NCLAT), the impugned order dated 23.06.2022 of National Company Law Tribunal, Jaipur Bench has been set aside and hence the status of the Company came outside the purview of the Insolvency and Bankruptcy Code, 2016 w.e.f 06.01.2023 and the powers of the Board of Directors of the company had also been resumed.
